Sub: NOTICE INVITING NOMINATION PAPERS TO ELECT THE EXECUTIVE COMMITTEE MEMBERS FOR THE TWO YEARS TERM 2022-23 BEGINNING ON 1ST OCTOBER 2022.

In accordance with Trade Organizations Act. 2013 and TOA Rules 13-21, and procedure laid down in clause 14-27 of Memorandum and Articles of associations of All Pakistan Bedsheets & Upholstery Manufacturers Association the Election Schedule for the term 2022-23 beginning from 1st October 2022, duly approved by the Executive Committee in its meeting held on **14th July 2022** is issued. The members fulfilling terms & conditions laid in Rules-11 provisions (a) to (e) of T.O Act Rules 2013 are hereby invited to furnish their nomination papers for the purposes to contest Annual Elections for the **Seven** seats of the Executive Committee (**4 seats** from the corporate and **3 seats** from the Associate class members). All The 7 (seven) member of the Executive Committee shall be elected by the General Body.

1. The General Elections shall be held by secret ballot during the month of Sep. 2022 and members renewed till 31st March 2022 are eligible to cast vote.
2. Right to vote shall accrue only the members duly approved by the Executive Committee and has completed two years of valid membership as on the date of announcement of election schedule. Provided that old members shall be eligible to vote on completion of one year of their Re-enrolment & payment of all dues.
3. A member is entitled to propose or second only one nominee for the above said vacancies.
4. Neither postal ballot, nor proxy will be allowed.
5. A member who desires to contest election of the Executive Committee must give his consent in written as provided in the nomination form. Each nomination paper should accompanied by a prescribed nomination fee Rs.20,000/- (Twenty Thousands only) (refundable prior to publication his name in the ballot papers) in shape of Cash/Bank Draft/Pay order in favor of APBUMA.
6. The right of vote at the time of election shall be allowed only to the Proprietor, Partner or Director of the member firm or company concern or a person not below the rank of General Manager authorized by the Board of Directors of the Public Limited Company or a multi national company only if his or her name already been registered with the Secretary General of association and his name appears on the list of voters. A voter should be identified by his valid original Computerized National Identity Card or identity card issued by the Association or passport, as well as specimen signature/ photo will be compared.

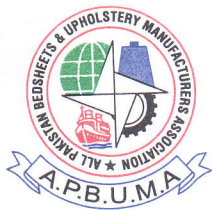


